Terms & Conditions

- 1) Presentations must be in the context of healthcare advances and performance benefit with the emphasis on technical development. Purely marketing-orientated papers will not be accepted.
- 2) The deadline for submitting abstracts is 31 March 2010.
- 3) Papers will be selected from the abstract. Important criteria for selection are the quality and originality of the content as well as relevance to the theme of the conference.
- 4) The abstract should consist of a 500-word summary of the contents of the paper and the main points to be made. Each abstract must be attached to a completed abstract registration form. Full details of the required length and format of the paper will be confirmed after selection for presentation. Please note, as a guideline the speaker will normally be asked to present a paper of approximately 25-30 minutes.
- 5) Papers should be presented by one speaker only. Authors will be notified by the 23 April 2010. Speakers will receive complimentary registration for the day of the presentation together with lunch and reasonable expenses.
- 6) Speakers selected to appear in the programme will be expected to honour their commitment. If circumstances change and they are no longer able to speak at the event the speaker will be expected to arrange a suitable alternative.
