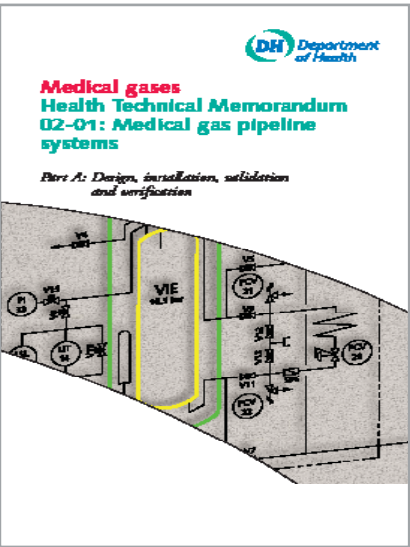

INSTALLATIONS

Our installations service includes pipework for new and upgrade projects, medical vacuum plant, medical air plant, manifolds, medical gas alarm systems, laboratory gases and Anaesthetic Gas Scavenging Systems (AGSS).

We plan each installation carefully with our customers, ensuring that our work causes minimum disturbance to hospital routines and is coordinated wherever possible with the work of other contractors.



Our installations are fully tested at each stage, and upon completion are certified in accordance with the requirements of HTM 02-01.

We have long-term relationships with a variety of suppliers, and can offer competitive rates for all items of MGPS plant.

We supply and install a wide range of medical gas alarm systems, including our own brand and other supplier brands.



Our installations are fully warrantied and all our SHJ-branded equipment is covered by our 5 year ‘no quibble’ warranty. This means that in the unlikely event our equipment has a fault, we will rectify the fault immediately and at no labour or material cost to the customer.

SHJ is committed to developing the best modern practices to manage a hospital’s MGPS in the most efficient way.

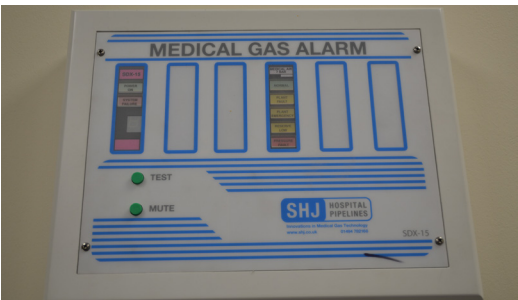

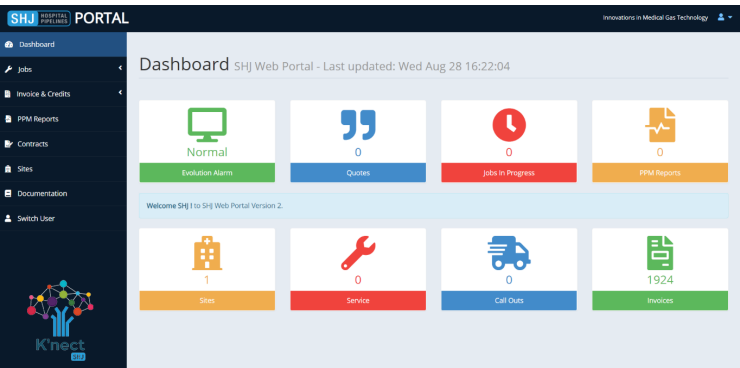

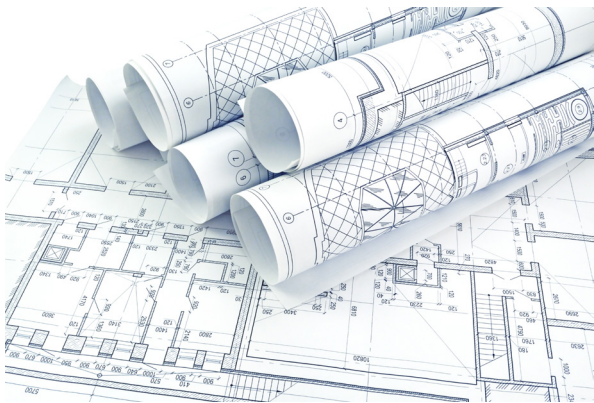

AUTHORISED PERSONS (MGPS)

HTM 02-01 stipulates that a fully experienced and qualified Authorised Person (MGPS) must be appointed to manage a hospital’s MGPS.



Operational Authorised Person

- ✓ Manages contracts, documentation and contractors
- ✓ Ensures safe site operation with a permit to work system
- ✓ Ensures MGPS compliance with statutory requirements
- ✓ Prepares, implements and monitors the MGPS operational policy
- ✓ Provides technical advice
- ✓ Attends meetings
- ✓ Advises on equipment purchases

Construction Authorised Person

- ✓ Provides onsite contractor training and advice
- ✓ Ensures safe site operation with a permit to work system
- ✓ Carries out tests to ensure standards are met
- ✓ Commissions the MGPS
- ✓ Assesses the competence of all Competent Persons (MGPS)

We can provide our customers with an Authorised Person (MGPS) in the absence of their regular Authorised Person or where there is no directly employed Authorised Person onsite.

ACCREDITATIONS

Our standards comply fully with the requirements of the Health Technical Memorandum 02-01: Medical Gas Pipeline Systems.



We are a Company Affiliate Member with the Institute of Healthcare Engineering and Estate Management (IHEEM).

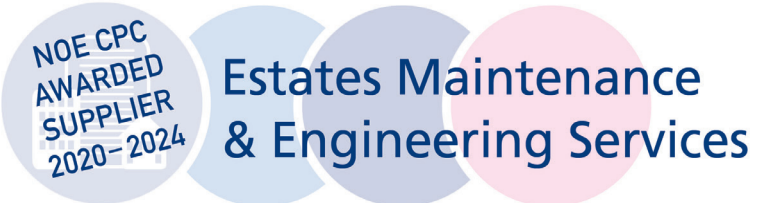
We hold SafeContractor and CHAS accreditation and are Constructionline Silver Members.
