It is essential that regular cleaning of the Kitchen Grease Extract System is undertaken to ensure compliance with current legislation.

If not professionally maintained, areas such as the ductwork and fan could be the source of a fire. 70% of all commercial kitchen fires originate from poorly maintained grease extract systems.

Regular cleaning will also make sure you are maintaining the efficiency of the system and will keep the grease deposits to a minimum.

To comply with the B&ES (formally HVCA) Guide to Good Practice: 'Internal Cleanliness of Ventilation Systems' TR/19 and the Health & Safety at Work etc. Act 1974, it is recommended that the following typical cleaning frequencies are followed:

Heavy Use 12-16 Hours per day 3 monthly
Moderate Use 6-12 Hours per day 6 monthly
Light Use 2-6 hours per day 12 monthly

Legionella Risk Assessments

Hygiene Contracts are members of the Legionella Control Association and can help you comply with current legislation by undertaking a legionella risk assessment at your premises.

Any water system, with the right environmental conditions, could be a source for Legionella bacteria growth. It is a legal duty to identify and assess whether there is a risk posed by exposure to legionella from the hot and cold water systems.

There is a reasonably foreseeable Legionella risk if your water system;

- a) Has a water temperature between 20-45 degrees C
- b) Creates and/or spreads breathable droplets, e.g. aerosol created by cooling towers or water droplets or even taps
- c) Stores and/or re-circulates water
- d) Is likely to contain a source of food for the organism, e.g. presence of sludge, scale or fouling

Legionella Risk Assessments need to be carried out by employers, landlords and anyone that has a responsibility of the control of water systems in general and should be reviewed if changes are made to the layout of the domestic water systems.

Water Hygiene And Treatment

Cleaning and disinfection of water storage tanks is one of the key factors in ensuring there is a clean water supply to a building. Potentially fatal bacteria such as legionella can proliferate in water systems where conditions have deteriorated due to being neglected.

Hygiene Contracts are members of the Legionella Control Association and can undertake clean and disinfections to cold water storage tanks in accordance with current legislation.

On completion of the works a certificate is issued along with a comprehensive report showing pre and post pictures of the works.

Fire Damper Drop Testing

Fire dampers working efficiently are crucial to ventilation systems. They are designed to prevent fire from being able to spread through the ductwork or other areas of a building.

If they are not working correctly or aren't installed into ductwork/ ventilation systems, it can cause fires/smoke to pass through the system quickly & into the building. Dampers can degrade over time & if not inspected as required, they can stop working efficiently or stop working at all.

When undertaking fire damper drop testing, all information will be compiled into a full comprehensive report with pre and post photographs and will include the location, damper identification number and we will advise if there are any signs of damage or corrosion. We will also confirm whether a clean of the ductwork is required and the level of dust/debris deposits in the system.

The certificate and report will be issued following completion of the works. To ensure you're compliant with legal requirements, contact us to arrange drop testing of the fire dampers to ensure they are working correctly.

BS 9999 – Code of Practice for Fire Safety in the Design, Management and use of Buildings states that you must ensure fire dampers are repaired or replaced immediately if found to be faulty.

It is highly recommended that you create a maintenance plan to ensure compliance and keep the fire dampers in a fully working condition.
