We continue to help members achieve professional status with more people now achieving Eng Tech and IEng and our Head Office team are handling more enquiries and processing applications than ever before. NHS and Company Affiliate memberships have increased this year which means that more companies and organisations who provide goods and services to our sector are taking advantage of IHEEMs offer. Most of the exhibitors at our national events. including Healthcare Estates, are IHEEM Company Affiliates

Our financial position remains strong which has enabled us to freeze membership rates for 2 years which I know has been welcomed during this period of economic uncertainty. ## **TRAINING & DEVELOPMENT BUSINESS PLAN CORE OBJECTIVES 1.2.4 AND 7**

### **HEJ TRAINING AND DEVELOPMENT SECTION**

The launch of a dedicated training and development section in 2024 is part of the Institute's commitment to support the professional development of its members. Each month this new section focuses on a different discipline within healthcare engineering and EFM, highlighting the work being undertaken to drive knowledge and standards within these sectors. Lead articles from IHEEM and its working groups are showcased alongside training insight from knowledge partners, which also serve to highlight the range of training opportunities available to members. A spotlight article features a given individual's professional experience and accomplishments within the industry, and we also highlight relevant Institute updates, resources and recognises members' achievements.

## **BOOK YOUR TRAINING WITH IHEEM**





### **IHEEM KNOWLEDGE PARTNERS**

We continue to work closely with twelve leading training providers to deliver members an extensive range of certified courses and qualifications to consider. Over 270 unique courses are available across myriad facets of engineering disciplines, and estates and facilities management. Through the HEJ Training and Development section, Knowledge Partners have the opportunity to share their expertise and relevance of their courses to members.



### **IHEEM COACHING & MENTORING SCHEME**

Work started in 2023 to develop this new programme which will be rolled out to IHEEM members next year. The Institute will be delivering training to it's body of mentors, and is developing an exclusive and confidential mentor-mentee functionality, which will be available through member login, for keeping a record of these relationships.







### **IHEEM POCKET GUIDES**

The Institute listened to feedback from its members and this year developed a userfriendly CPD Pocket Guide to help understand how to engage and record CPD activity. In making the processes accessible and easy to follow, the Institute continues to support the requirement of all registered individuals to maintain and enhance their competence. The guide builds on the Institute's resources available to members, and encourages and supports the use of the MyIHEEM CPD platform. The CPD guide is the first in a series of similar booklets that are now being developed including Professional Registration and Authorising Engineers.

## **EQUALITY, DIVERSITY & INCLUSION** BUSINESS PLAN CORE OBJECTIVE 1

Over the past few years the Equality, Diversity and Inclusion Working Group has been looking at many different topics including "Women in Engineering" and LGBTQIA+. This year the group focussed on the "Inclusion Ceiling" and what IHEEM can do to ensure that there is a a diverse and inclusive workforce at the highest levels within our sector.

The group welcomed two new members this year, David Stevens, Director of Estates, Facilities & Capital Development at East London NHS FT and Louise Clark, Technical Director at GPT Consult. Joining the existing five members, the group led a round table discussion at Healthcare Estates 2023 following the presentation by workforce leads at NHS England. The NHS Equality, Diversity & Inclusion Improvement Plan 2023 – 2028 looks to address discrimination and increase accountability of leaders as well as supporting levelling up and NHS anchor roles and the group discussed with conference delegates what barriers there are and ideas for improvement.

As in previous years, feedback from those who joined the discussion was extremely positive and the Working Group would like to thank everyone for sharing their knowledge and experience at these sessions.

Discussions have begun to agree the theme for next year which is likely to focus on mental health awareness and neurodiversity.

The full range of options available to members when considering professional registration was highlighted via our inaugural training article for the Health Estate Journal and is now available on the IHEEM website. Working closely with the Engineering Council UK, this clearly sets out how IHEEM recognises the importance of supporting individuals at all levels of experience and of differing circumstances, enhancing the accessibility of both registration, and professional development.

## **REGIONAL BRANCHES BUSINESS PLAN CORE OBJECTIVES 3 AND 5**

In addition to their regular meetings, IHEEMs Regional Branches have delivered a number of free events, seminars and site visits. These not only provide members with the opportunity to network and learn but also to gain valuable CPD. All Branch events are reported in IHEEM's Health Estate Journal and below are some highlights.

2023 saw the launch of the new IHEEM Branch Committee. Comprising of all Branch Chairs, this new group has been established to ensure consistency across all Branches, particularly in relation to marketing and brand awareness, as well as supporting IHEEMs Business Plan Core Objective 9 around strengthening the link between Branches and IHEEM Head Office.

In February, the West Midlands branch hosted a webinar that was open to everyone where officials from NHS England delivered a presentation on the Estates Returns Information Collection (ERIC) covering data analysis, current changes and future plans followed by an interesting Q&A and open discussion.

Following their visit to the UK in October, the Hong Kong Branch celebrated their 25th anniversary at their symposium titled, 'Hospital Engineering Design in the New Era of Environmental and Technological Development', in Kowloon. education sectors in Northern Ireland and the Republic of Ireland. Attendance was free for public sector professionals with key themes including Capital Procurement, Strategic & Masterplanning and Digital Transformation.



The West Midlands branch hosted a webinar in November to provide advice and guidance to help members plan and prepare for the operational winter pressures.



November also saw the Southern Branch mark its 400th in-person meeting by hosting an informal meeting for members which included presentations by IHEEM CEO and President and a tour of the St Marys Hospital Block B project alongside a CPD talk and a chance for everyone to network and relax.

The Yorkshire Branch ended 2023 with a CPD and networking event in early December where they welcomed members of a real estate healthcare team who led discussions on topics such as Minimum Energy Efficiency Standards and Estatecode and Green Leases.

# **TECHNICAL & ADVISORY PLATFORMS, BOARDS OF REGISTRATION (AE) BUSINESS PLAN CORE OBJECTIVES 2.5.7 AND 9**



Earlier this year two existing IHEEM Technical Platforms, Strategic Estates Management & Environmental Sustainability were relaunched as IHEEM Advisory Platforms. These new platforms were established to bring together a range of experts across specialist healthcare topics that, whilst not technical engineering specific, have an impact on the effective delivery of the healthcare estates built environment.

The new Strategic Estates Management Advisory Platform met in-person early in the year and has begun an ambitious long-term programme of work across a number of key topics including Healthcare Planning, PFI Expiry and Capital Projects. A detailed article about this group was featured in the IHEEM Training & Development section of HEJ in October. The group held a well-attended workshop at Healthcare Estates and one of the sub-group Chairs was a keynote speaker at the conference.

A new Mechanical Engineering Technical Platform was set up in 2023 and is chaired by IHEEM President Alison Ryan. It aims to provide an overview and support to members across aspects not already covered by existing platforms such as steam and pressure systems, pneumatics as well as cooling and refrigeration systems.

IHEEMs platforms continued to feedback on national standards and guidance documents. In particular the Electrical Technical Platform was engaged in the new work proposals in preparation for the next edition of BS7671 and IHEEMs ETP Chair presented on this topic at Healthcare Estates.

**SPOTLIGHT ON** DECONTAMINATION

The Decontamination Technical Platform (DTP) and Board of Registration AE(D) have had a busy year across a number of projects. They have also welcomed newly registered AE(D)'s to the groups. During the year they have held several virtual and face to face meetings, the last being held at the Eastwood Park Training centre. They have also organised training seminars on new steam battery technology and water supply testing.

The DTP have conducted studies on technical issues and produced IHEEM guidance to inform and support members across several topics. Work also began to extend the training framework to cover Pharmaceutical production and a small working group has been developed to assess the AE(D)training framework to see if any additional content is needed.

Another large piece of work developed by the IHEEMs BoR(AE) (D) has been the AE(D) audit forms in conjunction with the JAG organisation. This process is now working very well and has gained a strong reputation within the service in the audits carried out in the flexible endoscope decontamination departments. The DTP and AE(D) board have also been working closely with IHEEMs partner on the "Paper to Digital" programme which aims to develop software tools that digitise the current governance systems in relation to specialised AE audits

Alongside the development of this new software tool, a small group trialled and developed an evidence pre-audit tool for staff to collect, upload reports and results of such things as water test results. This will enable audits when carried out, to be conducted in a smoother manner. It will also guide users in understanding the reports and papers required for monitoring and electronically filing.

There is a third audit monitoring tool developed by this group which enables users to gather evidence, reports and documentation for the good management of the process. All three tools when used together will improve standards across the service as a whole, and assist greatly in the management of each individual department of hospital.

### **AUTHORISING ENGINEERS CONFERENCE 2023 IHEEM Key Events & Networking Programme 2023**

The annual IHEEM AE Conference was held in July at the prestigious Epsom Racecourse. The event titled "Delivering the Standard" saw around 200 delegates hear from key speakers and presenters on topics such as the importance of CPD and the role of APs and CPs. 6 members of the IHEEM Technical Committee also delivered an update of each of their groups key activities.

### **AE Audits: Strengthening Compliance**

A key session at this conference, and at Healthcare Estates, was the IHEEM "Paper to Digital" AE Audit Tool currently under development in partnership with Quigsolutions. Members of IHEEMs platforms and registration boards across a number of its technical specialisms have been involved in the development of this new software for AEs that aims to strengthen governance and assurance

> around the AE audit process. With the final work due to be completed by the end of the year, it will be made available free to IHEEM AEs in 2024.
