

HSL Compliance offer a number of services for closed circuit water systems, all focused on maintaining the performance by minimising the risk and damage from corrosion and scale.


And when pre-commission is required, we support with cleaning, flushing, sterilisation and chemical degreasing services, all in accordance with BSRIA guidance.



















Waste Water and **Effluent Treatment**

We also project manage the asbestos removal process for a number of clients, helping them with the specifications and managing their preferred removal contractors.

















Fire

In compliance with the Regulatory Reform (Fire Safety) Order 2005 (FSO), all nondomestic premises in England and Wales (including common areas to blocks of flats and housing) must have a fire safety risk assessment. The responsible person must maintain the fire management plan and ensure they have a plan for actioning any recommendations from the risk assessment.

Our experienced team of Fire Risk Assessors will conduct a thorough assessment at site, recording any hazards identified, the associated risk level and any recommended actions required to ensure compliance. An overall evaluation of risk will be allocated and a bespoke assessment produced.


